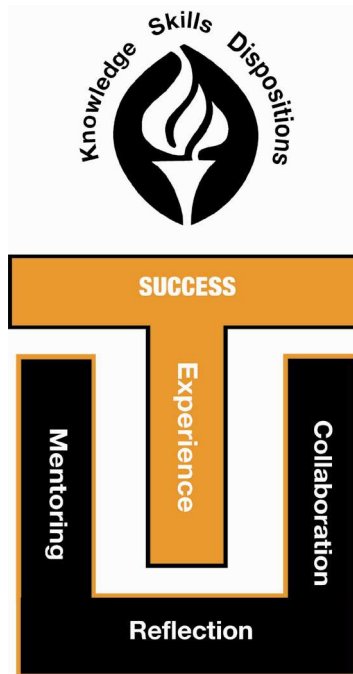

GUIDELINES FOR USING DOCUMENTATION OF INTERNSHIP EXPERIENCES

As an intern in the Teacher Education Program, you are to have a variety of experiences which will enable you to have a greater understanding of teaching.

The “Documentation of Internship Experiences” booklet serves three purposes: 1) it lists possible experiences (indicating those required) to be used in planning your schedule; 2) it provides a documentation of completed experiences to be used in evaluating your completion of the program; and 3) as part of your portfolio, it provides a valuable summary of experiences that you can use when seeking employment as a teacher.

Experiences to be completed during the Professional Year will be planned by the intern, principal, faculty liaison, mentoring teacher, and UT mentor. You are responsible for recording completed activities and obtaining authorized signatures.

Please consider the following guidelines:

How do I know what experiences I need to have?

Each major section, indicated by Roman numerals, has guidelines to explain which experiences you are to have. Some are mandatory; others allow for choice of experiences.

How long should I stay for each experience?

Since experiences vary in length according to grade level, the amount of time you spend at a site should be determined by you and your team of advisors (principal, faculty liaison, mentoring teachers, and UT mentor).

How do I document my experiences?

For each experience, provide the specific site and date. Provide a brief description of what you did and what you observed during that particular experience.

What is an authorized signature?

For each entry, you should obtain the signature of the teacher or other supervising individual who observed you in the experience. For example, if you observe in a special education class, you would have the special education teacher sign your documentation form. If you are unable to obtain the signature of the person directly involved in an activity, you may have your mentoring teacher or principal sign your documentation.

What do I do with the booklet when I’ve completed the requirements?

Your 574/591 instructors will answer any questions you might have about these assignments. Your 591 instructor will collect your *Documentation of Internship Experiences* booklet and evaluate its contents. He or she will provide feedback and will return the booklet to you for your files. In the past, we have found that interns have used this booklet in interviews during their job searches.
