Main Grant Objectives: (1) Ripple effect evaluation will confirm that peer recovery support (PRS) professionals support 12 or more families annually; (2) Hybrid PRS training will certify 290 participants across two years; (3) Hybrid PRS certification will contribute to employment of 25% of graduates; (4) Asynchronous PRS certification will add 10 certified supervisors; (5) Application of usability assessment findings will ensure that 3 workforce development programs (CPRS, CYAPSS, and Pharmacy) are accessible for all technology skill levels

Main Grant Objectives: 1) model and predict risks and healthcare service demand associated with behavioral illness in rural communities, 2) capture and quantify social perception and public concerns on novel healthcare delivery services, 3) establish innovative healthcare service paradigms by scheduling and coordinating mobile resources (e.g., mobile clinics/trucks and drones) to safely and efficiently meet customer demand, and 4) merge these elements to develop a Rural intEgrAtive Connected Healthcare (REACH) software platform that will be piloted and tested through close collaboration with local community stakeholders.

Main Grant Objective: *COURAGE* will address two overarching goals: (1) prevent opioid use disorder (OUD) with an emphasis on youth and the adults who care for them and (2) enhance OUD treatment and recovery by promoting integrated, interdisciplinary care.

Principal Responsibilities: As PI, I am responsible for ensuring the use of evidence-based practicing, monitoring deliverables and the timeline, and coordinating the efforts of four community-based organizations with the University of Tennessee (Public Health, Pharmacy, and the SMART initiative).
