# ITEM 2: REVISE TO REMOVE CREDIT RESTRICTION

Repeatability: May be repeated if topic differs. Maximum 9 hours. Recommended Background: 6 graduate hours in the major or consent of instructor.

Formerly: Credit Restriction: Maximum 3 hours may be applied to child and family studies specialization electives for the master's degree.

# **SUPPORTING INFORMATION:**

Rationale: Removing the credit restriction of only 3 hours being applied to the CFS specialization electives for the master's degree will make this consistent with the CFS master's program requirements, which do not restrict the use of CFS 580 in the specialization electives. Thus, this fixes an inconsistency between the program requirements and the course description for CFS 580.

Repeatability: May be repeated if topic differs. Maximum 6 hours. Recommended Background: 12 graduate hours in the major or consent of instructor. Registration Restriction(s): Minimum student level – graduate.

Formerly: Credit Restriction: Maximum 3 hours may be applied to child and family studies specialization electives for the master's degree.

Rationale: Removing the credit restriction of only 3 hours being applied to the CFS specialization electives for the master's degree will make this consistent with the CFS MS program requirements, which do not restrict the use of CFS 610 in the specialization electives. Thus, this fixes an inconsistency between the program requirements and the course description for CFS 610.
